

LETTER OF ORGANISATIONAL APPROVAL 12/2024
CONDITIONS AND LIMITATIONS OF ORGANISATIONAL APPROVAL

1. The recertification of Organisational Approval to AIROD Sdn Bhd - Alor Setar as an AMO is made contingent upon the following conditions and limitations:
 - a. The AMO shall be limited to perform Organisational Level Maintenance (OLM) and Intermediate Level Maintenance (ILM) for PC 7 MK II aircraft as defined in the Maintenance Management Plan (MMP), performed under the agreement/contract KP/PERO3B/RT210/2020/OE JIL 3 (7) dated 20 Dec 2023.
 - b. AIROD Sdn Bhd shall comply with all applicable clauses of Regulation 4 and 5 of PU 2103 – Technical Airworthiness Management Manual (TAMM) 2nd Edition.
 - c. AIROD Sdn Bhd shall manage maintenance in accordance with the approved latest revision of the MMP.
2. The State Technical Airworthiness Authority shall be advised of any changes to the information in the MMP or in any of the other principal plans listed therein. Therefore, changes in any of the organisation's manuals and instructions which are referred to in these principal plans must also be communicated to the Directorate General Technical Airworthiness (DGTA).
3. AIROD Sdn Bhd staff member who is responsible for the maintenance management aspects of the organisation shall be the Senior Maintenance Manager (SMM). Hence, the SMM will be the signatory responsible for the certification and approval of all documentations related to the maintenance works.
